

Southwest Volleyball Club PLAYER CONTRACT 2023

It is agreed between _____ (the Athlete), and _____ (the Parents) and Southwest Volleyball Club (SWVC) that this Athlete will participate in the 2023 season of Junior Olympic Volleyball on the following team and pay the appropriate club dues. _____

SWVC agrees to honor all commitments and information regarding the Athlete with regard to practice time, coaching instruction, number of tournament play dates and other services common to a volleyball team. SWVC will be familiar with the appropriate eligibility guidelines for each state High School Association from which they draw Athletes and adhere to these guidelines.

Athlete and Parents agree to

1. Pay all SWVC fees in a timely fashion according to due dates; payment options are noted at the end of this contract. Athlete and Parent realize that failure to pay fees by stated due dates and in full by March 15, 2023 may result in the Athlete being suspended from full participation with the team or may result in the suspension or dismissal from SWVC; extreme financial hardships will be addressed on an individual basis.
2. Become familiar with and adhere to all SWVC team rules and regulations as published as "Southwest Club rules & regulations 2023", which may be viewed or printed from SWVC's website: www.Southwestvolleyballclub.com.
3. Attend all practices and tournaments unless prior agreements were made with the coach.
4. Athletes and Parents understand that if a team qualifies for Nationals, the fee is already included in the Club Dues and Athletes agree to attend, regardless of location.
5. I/we the undersigned Athlete/Parent, on behalf of myself, my heirs, legatees, and assigns, hereby agree to indemnify, save, and hold harmless the Southwest Volleyball Club, Splash Zone & the Christian Community School or any of their agents, representatives, employees, or assigns for my health, safety, or any other injury and/or disability arising out of or resulting from participating in the Southwest Volleyball Club program. As an Athlete/Parent in the program, I/we recognize and acknowledge that there are certain risks of physical injury and I/we agree to assume the full risk of any injuries, including loss of life, damages or loss which I/we may sustain as a result of participating in any and all activities connected with or associated with such a program.
6. I/we consent to the use of my name and likeness in any medium in connection with promotion, publicity or news reportage.
7. Athlete and Parent understand that playing time is at the coach's discretion solely and that the payment of fees does not guarantee playing time.
8. I/we agree to purchase the required uniform package (approx. \$150-\$200) according to information provided by SWVC and by the stated deadline.

National team players require a much higher level of commitment to their team. You must be willing to guarantee at least 95% of practice attendance, even if playing other high school sports. Players are expected to travel to all National Qualifiers and the Girls Junior National Championships if the team qualifies. Senior age Athletes and Parents understand that seniors are required to be planning to or attempting to further their careers playing college level volleyball next year and will make a serious commitment to practice and tournament attendance for the benefit of the team.

Athlete and Parent understand that no refund of fees paid will be given for players leaving the team either through their decision or the SWVC's, or if unable to participate due to injury, and they are still responsible for any remaining fees due.
